- Safeguarding Lead (Arzu Aydin) for Child Protection, and two deputies (Umesh Patel & Shani Kaur).
- Named Governor for Child Protection is Mr Steve Martin.
- All staff have up to date training for Safeguarding and Child Protection.
- Clear procedures are in place to ensure that any suspicions about neglect or abuse are reported to DSLs/relevant agencies.
- Notes of concern are recorded on CPOMS as evidence of ongoing concerns about children.
- Dedicated area on school website for safeguarding and child protection

Behaviour

Recruitment

- Head and members of the Senior Leadership Team are trained in safer recruitment when interviewing new applicants.
- Safer recruitment procedures are followed (Safer Recruitment Policy)
- SCR (Single Central Record) managed & checked by Safeguarding Governor
- Robust Induction process by key members of staff

INDICATORS OF ABUSE (Appendix 1)

NEGLECT - persistent failure to meet a child's basic physical and/or psychological needs.

PHYSICAL - causing physical harm or when a parent/carer fabricates the symptoms of, or deliberately induces, illness in a child.

SEXUAL - involves forcing or enticing a child to take part in sexual activities. This may also include non-contact activities such as showing sexual images.

EMOTIONAL - persistent emotional maltreatment of a child. It may involve conveying to children that they are worthless or unloved.

Sexual Violence and Sexual Harassment (Child on Child Abuse) (Guidance - Appendix 9).

We must be aware that children can abuse their peers through this way, and that it can happen both inside and outside of school. Sexual violence and sexual harassment exist on a continuum and may overlap; they can occur online and face to face (both physically and verbally) and are never acceptable.

Sexual harassment is unwanted behaviour of a sexual nature which:

- violates your dignity
- makes you feel intimidated, degraded or humiliated
- creates a hostile or offensive environment

Sexual violence covers a wide range of behaviour, including:

- rape
- assault by penetration
- a single act of kissing someone without consent or touching someone's bottom/breasts/genitalia without consent, can still constitute sexual assault
- causing someone to engage in sexual activity without consent could include forcing someone to strip, touch themselves sexually, or to engage in sexual activity with a third party.

Child sexual exploitation (CSE) is a type of sexual abuse. When a child or young person is exploited they're given things, like gifts, drugs, money, status and affection, in exchange for performing sexual activities. Children and young people are often tricked into believing they're in a loving and consensual relationship. This is called **grooming**. They may trust their abuser and not understand that they're being abused.

Sharing Nudes & Semi Nudes (formally Sexting) can also form part of CSE both online and offline. **Upskirting** is the act of taking a photograph of underneath a person's skirt without their consent. Child Criminal Exploitation (CCE) occurs when an individual or group takes advantage of an imbalance of power to coerce, manipulate or deceive a child into criminal activity.

County Lines - Criminal exploitation of children is a widespread form of harm that is a typical feature of county lines criminal activity: Common features in county lines drug supply is the exploitation of young and vulnerable people.

Modern Slavery & Trafficking

Slavery is an umbrella term for activities involved when one person obtains or holds another person in compelled service.

Female Genital Mutilation (FGM) is an illegal operation under the Female Mutilation Act 2003 and is a form of child abuse. It is a mandatory responsibility of all staff members to report any suspicion of FGM to the police.

Child Missing In Education - A pupil missing from school can be an indicator of abuse/neglect. We have clear first day of absence procedures (Appendix 3).

RESPONSES TO CONCERNS

Police

Operation Encompass (OE) is a national operation that connects the Police with schools to share information about children who are subject or witness to police-attended incidents of domestic abuse. DSLs will inform relevant staff when an OE call has been received.

Social Care

Early Help (EH) provides consent-based support to families which can help to prevent an escalation of concerns. **This can include Team Around the Family (TAF).**

Child In Need (CIN) - Voluntary for families and gives children the opportunity to thrive with support from extra services.

Child Protection (CP) is considered when a child is suffering, or likely to suffer, significant harm. The Local Authority will make them subject to a CP plan.

MANAGING & REPORTING CONCERNS (Appendix 8)

LISTEN carefully to the child. You may ask questions of a clarifying nature – such as 'who, what, where, when, how?' or use the acronym TED – 'Tell me, 'Explain it to me', Describe it to me.'

REASSURE the child but do not promise confidentiality.

RECORD the incident accurately including date/time.

INFORM a DSL and handover completed record.
